The Regular Board Meeting was held on Wednesday, November 5, 2025, at the Township of Lyons, 6404 Joliet Road, Countryside, Illinois, 60525. The meeting was called to order at 6:00 p.m. by President Hoffenberg.

A new board member will be sworn in at the next meeting.

The Village of Bridgeview's facility service dog has been delayed; however, the Township's dog is scheduled to begin training to become a therapy dog. Once trained, the dog will visit agencies and participate in mental health-related events.

The LTMHC audit is still in progress and is expected to be completed by the end of the month. The November LTMHC Board meeting has been canceled. The next meeting is expected to take place in January, when the new commissioner will be sworn in.
